### Travel Free

TravelFree is our enhanced version of this standard legislation, not only giving you access to UK bundles and rates within the listed EU Zone 1 destinations, but also covering destinations further afield. This allows end users to utilise their home tariff package in a number of destinations worldwide with no daily fees or monthly cost uplifts. Destinations covered by TravelFree are split into two bands:

- Band A offers access to standard UK allowances (UK rates apply when out of bundle)
- Band B gives users the same access to bundles as Band A does, but roaming rates apply when out of bundle.

#### Travel Free Destinations - Band A

EU Zone 1 – Austria, Belgium, Bulgaria, Canary Islands, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, French Territories, Germany, Gibraltar, Greece, Hungary, Iceland, Ireland, Italy (inc. ### Travel Plus

TravelPlus is an alternative to World Travel Select (WTS), available on Daisy Alliance tariffs and is aligned directly with TravelFree. Like WTS, it offers an alternative to pence per minute rates in the form of an opt-in daily roaming rate of £5 exc VAT per day and will allow users full access to their UK bundles and allowances whilst roaming in a selection of worldwide destinations.

This must be opted into at point of sale and specifically covers data usage, SMS and calls in country and/or back to the UK within the below listed countries.

### Points of Note

All connections are subject to standard terms and conditions and prices are based on a 24-month minimum term.

1. Fair Usage Policy – Although we do not specifically restrict the amount of standard minutes and SMS messages available to each end user, devices must be used for purpose, as such Daisy does not allow SIMs to be used in any equipment which enables the routing of calls or data (including without limitation, text or picture messages) from fixed apparatus or standard devices to mobile equipment, by establishing a mobile-to-mobile call or transmission. Nor does it allow the use of any equipment which enables the sending of bulk SMS, voice or data services. Daisy reserves the right to suspend service without notice, should we believe that such equipment is being used. During suspension, the liability for any access charges or calls will rest with the customer.
2. Prices and tariffs are subject to change. Daisy will ensure at least 30 days' notice is given before any changes take effect.
3. Early termination fees – These are applicable in all cases where a cease request (PAC or disconnection) has been submitted and the minimum agreed terms have not been completed. This fee is determined based on the pro rata cost of line rental remaining from the subscription's date of cease up to the end of the agreement, including any required notice periods.
4. Bolt-ons – Daisy O2 Tariff, shared bolt-ons are applied at account level and not per mobile phone number. As such only one type of each bolt-on is available per account and they cannot be stacked or duplicated. Please also note that Daisy O2 Tariff account level bolt-ons are developed to only work alongside Daisy O2 Tariff and as such, if you apply a bolt-on to an account that has other O2 tariffs, users will not benefit from the additional allowance but may be charged.
